North Carolina's 1.5 Million Missing Voters



There are at least 1.5 million North Carolinian voters who are "missing" from our elections due to structural barriers. These voters include:

- At least 500,000 North Carolinians who are eligible to vote but not registered to vote.
- Nearly 1 million registered voters who did not vote in the 2022 and 2024 federal elections (i.e., "inactive" or "infrequent" voters).


That's more than the combined population of Charlotte and Raleigh, North Carolina's two biggest cities.

Black, Latino, and younger populations are disproportionately represented in both categories of missing voters.

ELIGIBLE VOTERS IN NORTH CAROLINA

Each circle represents 10,000 people.

- Missing voters who are inactive but registered to vote (approx. 1 million)
- Missing voters who are not registered to vote (approx. 500,000)
- Regular voters (approx. 6.5 milion)

North Carolina is one of the hardest states to vote in.

- NC ranks 30th in the nation in voting accessibility, dropping 14 spots in just for years, the nonpartisan Cost of Voting Index found.
- NC's drop in ranking was the largest in the country, indicating voting has become harder for North Carolinians.

RECOMMENDATIONS

What we need to find and engage these missing voters:


- **More funding and resources** for state and county election boards to increase voter engagement.
- **Automatic voter registration**, through government agencies, including the DMV (with the option to opt out).
- Expanded registration opportunities including Same-Day Voter Registration on Election Day and additional online voter registration opportunities.
- Automatically re-register people to vote after completion of felony sentences.
- Robust language assistance for voters.
- Reformed voter list maintenance practices.

GEOGRAPHIC BREAKDOWN

There is significant variation in the proportion of inactive voters by county, ranging from 9% of registered voters (Alexander County) to 19% (Hoke County). Several counties (Anson, Cumberland, Gates, Halifax, Harnett, Hertford, Hoke, Onslow, Robeson, and Tyrell) categorized more than 16% of their registered voters as inactive.
